3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to reproduce moulds and crafted ceramic pieces by moulding by a plastic mass or barbotine mass (ceramic slip), following given technical instructions and occupational risks prevention and environmental management regulations. This general competence is specified in the following **competency units** (UC):

- Reproduce moulds from dies for the reproduction of crafted ceramic pieces (UC 1684_1).
- Reproduce crafted ceramic pieces using moulds (UC 1685_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Reproduction of molds for the reproduction of crafted ceramic pieces (MF 1684_1).
- Reproduction of crafted ceramic pieces using molds (MF 1685_1).
- Practical training at the workplace in reproduction of molds and crafted ceramic pieces (MP0457).

(See legal basis for all learning outcomes acquired by the holder of this Certificate in every MF).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Participate in the process of making plaster moulds from the specifications settled in the operating method.
- Participate in the process of making resin moulds from the specifications settled in the operating method.
- Participate in the reproduction of crafted ceramic pieces by handicraft moulding of a plastic mass following the specifications established in the operating method.
- Participate in the reproduction of crafted ceramic pieces by collage, following the specifications of the operating method.
- Collaborate in the process of finishing and drying of the ceramic pieces reproduced from fragments, and following the procedure established in the given work methodology.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the craft sector in pottery and ceramic subsector, in the plastic arts and other industrial sectors that required his skills. The most relevant occupations and work positions are:

- Ceramic mould-model maker (porcelain, earthenware, clay and stoneware).
- Assemblers of ceramic products.
- Operators of tableware, household items and ornaments fabrication.
- Operator of moulds for handicraft ceramics.
- Operator of reproduction of crafted ceramics using moulds.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1521/2011, of October 31st, by which six professional certificates of the professional family "arts and crafts" that are included in the National Repertoire of professional certificates are established. (Appendix I, Code: ARTN0110).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
