3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to carry out extractive activities of fishing and shell fishing on board using different types of gillnets, traps and shellfish equipment, taking care of its maintenance, and subsequent classification and preservation of the catches on board, fixing, manoeuvring and steering of the vessel, following instructions from a superior and meeting the standards of safety and security. This general competence is divided into the following **skill units**(UC):

- Contribute to the on deck operations on a fishing vessel (UC0010_1).
- Carry out navigation watch-keeping and handling of the vessel (UC0011_1).
- Carry out extraction activities of fishing and shell fishing at the sea with fishing gear, traps and shellfish equipment (UC0734_1).
- Participate in maritime emergencies and implement safety measures at work (UC0733_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- On deck operations in a fishing vessel (MF0010_1).
- Watch-keeping navigation and handling of the vessel (MF0011_1).
- Fishing with minor fishing gears, traps and shellfishing equipment (MF0734_1).
- Safety and first aid on board (MF0733_1).
- Practical training at the workplace in fishing activities with gillnets, shellfishing, and on board (MP0317).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Use basic navigation and ship handling equipment and apply emergency procedures during a watch-keeping service.
- Apply fishing techniques as well as preservation procedures on board to the catches and the maintenance of the equipment and supplies of gillnets and shellfish gears.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the maritime and fishing industry sector, particularly in the extraction of fishery resources; and in services for the maritime transport of goods and rescue and maritime safety services. The most relevant occupations and work positions are:

- Gatherer of shellfish.
- Fishing sailor.
- Boatswain
- Shellfish gatherer on board.
- Sailor (ordinary seaman).

The holder of this professional certificate can be recognised by the title of fishing sailor according to Royal Decree 36/2014, which regulates the professional titles of fishing sector, following the established procedure and the authorised centers.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1533/2011, of October 31st, the seven professional certificates of the Professional Family of Maritime and Fishing Industries, included in the National Repertoire of professional certificates. (Appendix I, Code: MAPN0110).

Amended by Royal Decree 622/2013 of August 2nd, by which a professional certificate of the Professional Family of Maritime and Fishing Industries, included in the National Repertoire of professional certificate is established, and the professional certificates established as Appendix I, II and III of Royal Decree 1533/2011, of October 31st, and Appendix I, III and IV of Royal Decree 1774/2011, of December 2nd are updated.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
