3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to repair breakages and damage and/or replace pieces in any kind of footwear or leather goods, applying the necessary techniques and procedures without supervision, or if necessary under the supervision of a superior, restoring the article with the required quality and finish, within the deadlines and under environmental and safety conditions, providing the appropriate customer service demanded by the work in question. This general competence is divided into the following **skills units** (UC):

- Organise the materials needed and deal with customers for footwear repair (UC0438_1).
- Repair leather goods (UC0439_1).
- Repair footwear (UC0440_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Materials and services for the repair of footwear and leather goods (MF0438_1).
- Repair of leather goods (MF0439_1).
- Repair of footwear (MF0440_1).
- Practical training at the workplace in repair of footwear and leather goods (MP0214)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Receive and store raw materials and articles for repair, in accordance with established criteria and instructions.
- Prepare the materials, tools, machines and equipment needed for the repair of leather goods and footwear, acting under safety regulations.
- Repair footwear and/or leather goods, preparing and operating equipment, carrying out the automatic quality control established by the company.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the footwear sector, in the sub-sector of repair and conservation. The most pertinent occupations and positions are:

- Shoemaker/shoe repairer.
- Preparer of leather goods for sewing.
- Preparer of pieces for sewing and assembly of footwear. Footwear repair assistant.
- Leather goods assistant.

5. OFFICIAL BASIS OF THE CERTIFICATE
<p>Name and status of the national/regional authority providing accreditation/recognition of the certificate</p> <p>The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.</p>
<p>Level of the certificate</p> <p>The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>
<p>Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none">- FAIL: 0 to 4.9- PASS-SATISFACTORY: 5 to 6.9- PASS-GOOD: 7 to 8.9- PASS-EXCELLENT: 9 to 10
<p>Access to next level of education/training</p> <p>This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.</p> <p>For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>
<p>Legal basis</p> <p>Royal Decree 722/2011 of 20 May, establishing five professional certificates in the professional family Textile, Clothing and Leather, which are included in the National Repertoire of Professional Certificates.(Appendix I, Code: TCPC0109)</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
