#### 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to propose and perform, as required, image changes through transformation and beautification of hair and facial hair, advising customers according to their needs and required techniques, and direct and manage professional and business activities linked to provision of technical-artistic hairdressing services in various settings. This general competence is divided into the following **skills units** (UC):

- Advise customers on their personal image, through care and aesthetic transformation of hair and facial hair (UC0793\_3).
- Perform total or partial hair colour changes (UC0348\_2).
- Cut hair and trim and shave beards and moustaches (UC0351 2).
- Perform technical protocols and hairstyles for hair salons and audiovisual and stage productions (UC0794\_3).
- Direct and manage activities carried out by personal image companies (UC0795 3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Hairstyling consultancy (MF0793\_3).
- Hair colouring (MF0348\_2).
- Haircuts and complementary techniques (MF0351 2).
- Technical protocols and hairstyles for hair salons and audiovisual and stage productions (MF0794\_3).
- Management of personal image companies (MF0795\_3).
- Practical training at the workplace module in Technical-artistic hairdressing (MP0170)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Apply interview, observation and other techniques to obtain information on customer image for hairstyling or audiovisual and stage media.
- Design hairstyles and updos and prepare proposals.
- Apply total or partial hair colour change techniques, adapting them to customer characteristics and demands.
- Perform partial or total bleaching to change hair colour and supervise or perform the technique, taking into account customers' hair characteristics and their demands.
- Perform partial or total colouring or bleaching of eyebrows, beards and moustaches.
- Perform various haircut techniques and styles according to customer characteristics and demands, complying with necessary safety and hygiene standards.
- Perform beard and moustache shaving and trimming techniques adapted to customer characteristics and under safety and hygiene conditions.
- Apply temporary changes as the basis to prepare hairstyles and updos with classical and advanced techniques.
- Collaborate in the supervision of permanent changes as the basis to prepare hairstyles and updos with classical and advanced techniques.
- Apply techniques to do hairstyles and updos associating different technical tasks to adapt them to customer demands and needs or those of audiovisual, stage or advertising media.
- Use specific computer applications of the personal image area to manage hair salon activities.
- Apply criteria and parameters to evaluate service quality, analysing outcomes and actions to be implemented to achieve expected results.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies providing hairdressing services and hairstyle consultancy, television, filmmaking, theatre, fashion, advertising and cosmetic equipment manufacturers. The holder may also work in personal image services in the hospitality sector: hotels, spas; Social services sector: nursing homes; other Personal service sector: advertising agencies, fashion-modeling agencies, audiovisual media, stage productions and fashion, and hairstyling trade journals. The most pertinent occupations and positions are:

- Technical-Artistic Manager of hairdressing business.
- Hairdressing Technical-Artistic manager in audiovisual and stage productions.
- Artistic hairstyle adviser.
- Hairdressing manager.
- Hair products and equipment demonstrator.
- Hair product and service consultant.
- Hairdressing products, equipment and techniques Trainer.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

#### Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

#### Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

#### **Grading scale/Pass requirements**

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9

- PASS-SATISFACTORY: 5 to 6.9

PASS-GOOD: 7 to 8.9PASS-EXCELLENT: 9 to 10

#### Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

#### **Legal basis**

Royal Decree 716/2011 of 20 May, establishing five professional certificates in the professional family Personal Image, which are included in the National Repertoire of Professional Certificates. (Appendix V, Code: IMPQ0109).

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- B. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6

months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training

#### **Entry/access requirements:**

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
