3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to planning and coordinating the complete processes of editing and post-production in cinema, video and television, controlling the state and availability of equipment and materials, editing and integrating post-production tools according to the indications of the director or producer, using the holder's own criteria. This general competence is divided into the following **skills units** (UC):

- Plan the process of editing and post-production of an audiovisual product (UC0947_3).
- Prepare the materials and effects needed for editing and post-production (UC0948_3).
- Carry out the editing, integrating post-production tools and materials from different sources (UC0949_3).
- Coordinate the final editing and post-production processes to generate the final audiovisual product (UC0919_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Planning of the editing and post-production (MF0947_3)
- Preparing the editing and post-production (MF0948_3)
- Editing and post-production operations (MF0949_3)
- Final editing and post-production processes (MF0919_3)
- Practical training at the workplace in Audiovisual editing and post-production (MP0166)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Prepare the editing and post-production by organising the materials and preparing the image, graphics and lettering effects.
- Carry out the editing/post production of audiovisual products, operating the equipment skilfully, applying the techniques of editing and introducing optical, dynamic and special effects.
- Carry out the final editing and post-production processes.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

The holder of this certificate can work in the audiovisual sector and operate professionally in the editing or post-production room of film and video producers, TV stations of any size, whether public or private, with limited or broad coverage, whatever their system of broadcasting, and in the communication departments of large companies. - On-set film editor.
- Image editor/linkage editor.
- Linkage editor.
- Film editor.
- Editor's technical assistant.
- Editor's assistant.
- Video editor/linkage editor.
- Post-production operator.

<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10

<p style="text-align: center;">Legal basis</p> <p>Royal Decree 725/2011 of 20 May, establishing five professional certificates in the professional family Sound and Image, which is included in the National Repertoire of Professional Certificates. (Appendix IV, Code: IMSV0109)</p>

<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
