3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to organise and participate in all the operations in the process of packaging pharmaceutical and similar products, controlling, coordinating and supervising the operation, start-up, maintenance and shutdown of the installations and equipment, abiding by and ensuring compliance with the rules on correct manufacture, guaranteeing the release and traceability of the batch, and supervising the established safety and environmental conditions. This general competence is divided into the following **skills units** (UC):

- Organise the production of pharmaceutical and similar products (UC0334_3).
- Check conformity of process materials, equipment, installations and conditions (UC0335_3).
- Coordinate and control the manufacture of pharmaceutical and similar products (UC0336_3).
- Guarantee the quality of the packaged products (UC0337_3).
- Abide by and ensure compliance with the safety and environmental rules in pharmaceutical and similar processes (UC0338_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Organisation in pharmaceutical and similar industries (MF0334_3).
- Areas and services in pharmaceutical plants and similar (MF0335_3).
- Coordination and control of the packaging of pharmaceutical and similar products (MF0336_3).
- Guarantee of the quality in the packaging of pharmaceutical and similar products (MF0337_3).
- Safety and environmental rules for the pharmaceutical and similar processes (MF0338_3).
- Practical training at the workplace in organisation and control of packaging of pharmaceutical products and similar goods (MP0289).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Manage the actions and documentation required in the planning and control of batch manufacture.
- Analyse the main stages of the dosing and packaging process of pharmaceutical and similar products.
- Analyse the quality control systems used in the packaging process for pharmaceutical and similar products.
- Analyse the safety measures relating to prevention, procedures and working methods in the chemical industry.
- Analyse the systems and devices used to prevent risks derived from the production process, relating the systems and devices with risk factors and the process and emergency operations.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in pharmaceutical and similar companies, in the production of pharmaceutical forms and similar products, such as cosmetics, perfumes, diet products, herbal remedies, special foods and household goods. This work is in the following sectors: pharmaceutical, cosmetics, special food, diet food, household goods, herbal remedies, parapharmacy and perfumery. The most pertinent occupations and positions are:

- Team leader in facilities for the packaging of pharmaceutical products and cosmetics.
- Machine operator manager for the manufacture and packaging of chemical products.
- Packaging area supervisor.
- Planning area supervisor.
- Area coordinator

The holder of this professional certificate has recognition of the basic level training in labour risk prevention, according to Annex IV of the Royal Decree 39/1997 of 17 of January approving the Labour Risks Prevention Act.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1534/2011 of 31 October, establishing five professional certificates in the professional family Chemicals, which are included in the National Repertoire of Professional Certificates. (Appendix IV, Code: QUIM0210)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
